#### 3.0 Minutes of the Previous AGM

- Had a loss of \$11,000 for the year. This has taken into account ground hire fees, referee
  payments, Insurance and reduced income from fewer teams. Loss primarily caused by Covid
  and increased insurance fees
- Closing members funds \$71,900.00

- Discussed insurance. 4 claims made during year. Scott /Chris to obtain report on these claims.
- Committee to obtain insurance quotes to see if costs can be reduced.

#### 8.0 Auditor's Report

Acceptance of Auditor Report moved by CK, Accepted by committee.

 Cost for report \$550.00. It was discussed and confirmed that as a Level 2 organization an Auditor is required. Scott Carpenter to look at sourcing an independent, retired Auditor with cheaper fees.
