Glen's encouragement and willingness to assist with the little things has made him an indispensable part of the team which has so ably run the Association on your behalf during the last year.

Wendy Dickfos' first official year as Secretary has shown the enterprise she has in attending to the secretarial tasks of the Association as well as to so capably the competitions run by the Association. The extra duties have not fazed her in the slightest and my thanks go to her also for her application to her tasks.

Selwyn Dickfos is one man whose efforts often go largely unappreciated. As our first 'full-time' referee there is probably no other person in the history of the Association who has refereed as many BCTA matches as Selwyn. I wish to thank him publicly for his constant enthusiasm toward a job which is often devoid of encouragement. Keep it up for as long as you want.

I began the Association for a number of reasons, but chief amongst them was the provision of an avenue whereby people can build friendships and share their lives and their love for God with others. I thank God that these objectives still remain. I ask forgiveness though for the times when I have lost sight of this objective. My prayer, though, is that this objective will never be lost amongst the mundane affairs of administration. To whoever it is who fills the role of President and those on the Management Committee this next Year I you not to lose sight of this.

My thoughts and prayers will be with you. I am happy to discuss with you anything that I have not passed on to others concerning the of the Association. And I will of course see many of you from time to time either in other spheres, or when I attend matches of the Association.
