10.2 Covid 19

Winter season and New Forest Lake competition on hold till all clear given to play again. Winter season may be a total write-off. Will look at playing a short 8-week competition if possible.

10.3 Forest Lake venue

- Opportunity to expand the competition is recognized with ability to start new competition at Forest Lake. Can look at running 3 x 12-week competitions per year. This would be on Wednesday night and will not interfere with the existing competition.
- Current lease is up and can be split between us and the Wasps junior rugby club. Split to be 50:50.
- Lease is \$10,000 p.a., with running costs also about \$10,000.
- Presently no touch competitions between Mt Gravatt and Springfield.
- The proposal looks financially sound with at minimum break even, or profit.

- Two x rugby fields available, one floodlit
- Venue is well set for carnivals and has its own clubhouse.
- Locker can be hired to accommodate equipment.
- Proposed that referees rotate venues to assist with consistency within BCTA.
- Plan would be to use some existing teams to maintain culture.
- Already interest from teams especially teams that came from Richlands comp.
- Propose to accept agreement for year as Joint Tenant.

All accepted proposal.

10.5 Payment Schedule

It was agreed by all that as the competition is now expanding and requiring more Involvement/ commitment the following payment schedule be adopted from start next season.

- Competition Director \$150.00 per week first venue, \$50.00 per week subsequent venues.
- Referee's Coordinator \$30.00 per week per venue
- Treasurer Annual \$200.00
- Secretary Annual \$100.00

Other comps more expensive. We will maintain \$990.00

We now have a core group of dedicated referees who turn up every week without fail. I would like to congratulate & thank these guys because without them we would be in struggle street.

A positive has been the addition of a couple of youngsters who have joined the referee ranks. They have been a breath of fresh air. They have reinvigorated some of us veterans & reminded us of the joys of what we do. I have had some inquiries but nothing concrete with regards to more juniors joining. We need to encourage more juniors/new referees so when we go back to Tennyson or a bigger venue we can facilitate more games rather than burning out our dedicated referees.

Another highlight was having a referee trainer/assessor come out for a month before the finals last winter. This definitely helped all with standards/interpretations which are enforced in the TFA. As we look to the future, as uncertain as it is, my greatest concern is we have lost the large pool of referees we once had back at Tennyson. The players/referees who could fill in for one or two allowed for rotation & rests when people needed them. When we go back to Tennyson or a larger ground, we will be thin on the ground until we grow that pool again. The catch is we will need quite a bit of new blood as father time catches up with the rest of us.

I would once again like to thank everyone who has refereed either once or every week. Without your effort & commitment, we wouldn't have a competition. I stand & applaud you.
